It is unlawful for any person to be employed in any occupation within a Restricted Area or Customs Area related to a port of entry if they have a conviction under the Misuse of Drugs Act 1972 or any other conviction for dishonesty under the Criminal Code.

NOTE

- The purpose of the Seaport Security Pass is to ensure that access to statutory Restricted Areas in port areas is controlled in accordance with the International Ship and Port Facility Security (ISPS) Code, the Bermuda Maritime Security Act 1997, the Merchant Shipping Act 2002 and the Customs Revenue Act 1898.
- There is a non-refundable Bermuda Police Service security vetting fee of \$100 per application payable at the Government Administration Building, Ground Floor Payments Desk. The receipt provided should be submitted with your application to Marine & Ports.
- There is a Marine and Ports pass processing/printing fee of \$80 payable at the Boats and Moorings Office, Paget (the former Paget Post Office). A copy of the Police Vetting Fee receipt should be included with the application(s).
- Digital photos of applicants should be submitted to seaportsecurity@gov.bm by the applicant sponsor.
- A pass is for identification purposes only and does not automatically confer right of access to the holder.
- Your pass is to be worn such that it is clearly visible at all times while you are in the Restricted Area of any port facility listed above.
- Passes are valid for 2 years, at which time a pass holder must re-apply and will be re-vetted prior to receiving a new pass.
- Passes **MUST BE** surrendered if the pass holder is no longer employed by the sponsor company listed on this application.
- A search of any person, articles, effects, vehicles and vessels entering or within the restricted areas may be undertaken at any time.
- Access control and search requirements may change at any time due to international maritime security (terrorism) requirements.
- A seaport security pass issued by the Corporation of Hamilton authorizes access to the Hamilton Cargo Docks only.
