### 1. EXHIBITION FEE

If the Selection Committee selects you as a vendor, you will be required to pay the following exhibition fee to Parks Department to operate as a vendor at the Exhibition:

<b>\$925.00</b>	<b>12x12 concession stand with electricity</b>
<b>\$1,265.00</b>	<b>14X14 concession stand with electricity</b>
<b>\$1,600.00</b>	<b>16x16 concession stand with electricity</b>

### 2. EXHIBITION DATES & TIMES

Participants must operate their exhibits for the full three (3) days of the Exhibition. Concession booths must be manned at all times according to the below tentative schedule, which may be modified by Parks Department.

Thursday, April 24 <sup>th</sup>	8:00am – 6:00pm
Friday, April 25 <sup>th</sup>	8:00am – 6:00pm
Saturday, April 26 <sup>th</sup>	8:00am – 6:00pm

### 3. ACKNOWLEDGEMENT

All applicants will be informed by email whether they have been selected as a vendor. Successful applicants will receive a confirmation email on **January 31<sup>st</sup>** with additional information. Incomplete application forms may not be accepted.

Concession fee must be paid in full by **February 21<sup>st</sup>** for the vendor to proceed and secure a concession booth within the Exhibition grounds.

### 4. REPLACEMENT

If the selected vendor decides not to participate in the Exhibition, it is the vendor's responsibility to find a suitable replacement, which must be approved by Parks Department. Vendor fees will not be refunded!

### 5. SIGNATURE:
