\$1,600.00	16x16 concession stand with electricity

2. EXHIBITION DATES & TIMES

Participants must operate their exhibits for the full three (3) days of the Exhibition. Concession booths must be manned at all times according to the below tentative schedule, which may be modified by Parks Department.

3. ACKNOWLEDGEMENT

All applicants will be informed by email whether they have been selected as a vendor. Successful applicants will receive a confirmation email on <u>January 31st</u> with additional information. Incomplete application forms may not be accepted.

Concession fee must be <u>paid in full</u> by <u>February 20th</u> for the Vendor to proceed and secure a concession booth within the Exhibition grounds.

4. REPLACEMENT

If the selected vendor decides not to participate in the Exhibition, it is the vendor's responsibility to find a suitable replacement, which must be approved by Parks Department. Vendor fees will not be refunded!
