Tenders are invited from Experienced Licensed Physicians or Medical Groups for the above captioned project. The purpose of this work is to ensure employees that handle poisonous and/or toxic substances, or are engaged in an occupation that requires special precautions, undergo annual medical examinations as per the respective trade union Collective Bargaining Agreement.
